Course Details: Race is around buoys 200 metres apart on Leven River opposite Anzac Park and between Hobbs Bridge and Railway Bridge. close to top-of-tide.

Deep-water start between shore marker and buoy at mid-course.

One boat on each side of course. Row two circuits of course.

Finish is across the respective start lines.

Marshalling Area is the sandy beach opposite Anzac Park, on the edge of Tobruk Park. Vehicle access to Tobruk Park is off Helen Street.

Boats may be launched at boat ramp near Recreation Centre OR at boat ramp south west of Rowing Club.

Surf Boat Pursuit Race Rules

1. Each race will be rowed over two laps.
2. Deep water start.
3. Random draw will be used to select pairs of boats for first round of races.
4. Second placed boat in each race is eliminated
5. Random draw for winners from round one to choose pairs of boats for next round of races.
6. Each team must keep the same crew for each race.
7. Rowers must be present to win Random Draw prize.
